Committee Updates

Academic Committee

- Principal Johnson shared SY22-23 goals and YTD classroom data
 - Goals are a 15% increase in proficiency for Black students and students with IEPs; and 75% of students grow 1.5 years in MAP assessment
- Presented and discussed achievement gap data, including where we see gaps in PARCC and where we see gaps in MAP
- Discussed interventions in place for students
- Data presentation will be shared with Andrea and updated regularly;
 Andrea will share with Board members
- Leah spoke with a Progressive Educators Network administrator about alternative assessments; will compile notes and share with school leadership
- Dr. Riggins is meeting with our selected equity consultant to move that process forward
- Next Academic Committee meeting is on Feb. 16

Head of School updates:

- In November, 80% of families joined the 1st in-person Learning Showcase since 2020
- ITDS participated in EdFest, which remained virtual this year
- It is now recruitment season our 1st Open House will be 1/12; we are offering in-person and virtual options
- Submitted an application last week for the Saul Vent Early Education Initiative Innovation Challenge, sponsored by Harvard Univ., focused on engineering; opportunity to engage kids in hands-on maker activities during out-of-school time
- COVID Mitigation: case numbers are rising right now; we are masking and testing to return after breaks

Academics

- Will be sharing connection between today's presentation and the Middle of Year testing data
- o Intersessions this year allowed for honoring more student choice, as Covid cohorts were less of a concern

Parent Engagement

- o IFA raised \$8,000 to give \$75 Amazon gift cards to staff before the holidays and hosted a dessert bar for the in-school holiday gathering
- o Beginning a Listening Series with parents Jan. 31

- Equity Work: Caroline Hill from 228 Accelerator is our chosen consultant; she'll
 be introducing herself to staff today and facilitating some staff affinity groups to
 gather data and share her findings in March. The long-term goal is to grow the
 capacity of our educators to talk about issues connected to race
- Equitable Access Preference:
 - o SY 23-24 will be Year 2 for the Equitable Access Preference
 - o Plan to offer the same number of student slots, at the early childhood level as last year
 - o Will have parent workshops to support their understanding of ITDS's approach to student voice and learning
